Attainable	We will be supported by the local authority through training and the provision of contacts and resource materials to make sure this Equality Objective is achieved in our school, enabling us to identify the issues and champion the best educational outcome for all our pupils.
Relevant	<i>“Evidence suggests that the positive impact is greatest on children from the most disadvantaged backgrounds (Hall et al., 2013; Maisey et al., 2013; Smith et al., 2009; Sylva et al., 2004). This suggests that early childhood education and care has the potential to make a key contribution to narrowing the gap in development between groups of children. Attending high quality early years education helps prepare young children to be ‘school ready’ and more able to take forward their learning when they start school (Becker, 2011), an important foundation for a successful educational experience improving their long-term life outcomes.”¹</i>
